Office of Arjundhara Municipality, Jhapa invites sealed bids from eligible bidders for Construction of first floor of Arjundhara Municipality Office Building, Canteen and Public toilet, Arjundhara-8, Jhapa.. A complete set of Bidding Documents may be purchased from the office by eligible Bidders on the submission of a written application, on or before 17:00 hrs 2074/11/20 (4th March, 2018) along with the copy of company/firm registration, business registration certificate, Vat and PAN registration certificate and tax clearance of fiscal year 2073/074 and upon payment of a non-refundable fee. Payment shall be in the form of cash deposit in office of Arjundhara Municipality or the bidder has to deposit cash in mul sanchit khata account no: 0600601149492035 of Arjundhara Municipality Office, Shanischare, Jhapa in Agricultural Development Bank, Birtamode Jhapa and shall submit bank deposit voucher along with bid.
4. Bids must be delivered to the Office of Arjundhara Municipality, Shanischare, Jhapa on or before 12:00 o'clock of 2074/11/21 (5<sup>th</sup> march 2018). Alternatively, bidders may submit their bid electronically through E-procurement section of PPMO's Web Site <http://www.bolpatra.gov.np>. As specified in the Instruction to Bidders. Late bids will be rejected. Bids will be opened physically and electronically at 14:00 hrs of 2074/11/21 (5<sup>th</sup> march 2018) after bid submission deadline in the presence of representatives including bidders (who choose to attend) at Office of Arjundhara Municipality.
5. All bids shall be accompanied by a valid bid security of an amount not less than the amount as specified below. The bid security guarantee issued by only the A class commercial bank approved by Nepal Rastra Bank shall be accepted by the employer. If the bidder wishes to submit the bid security in the form of cash, the bidder has to deposit cash in deposit account no: 0600601149492094 of Arjundhara Municipality Office, Shanischare, Jhapa in Agricultural Development Bank, Birtamode Jhapa and shall submit bank deposit voucher along with bid. Bid security shall remain valid upto 120 days from the date of bid opening.
7. Pre-bid meeting will be held in the Office of Arjundhara Municipality, Shanischare, Jhapa at 14:00 hrs on 2074/11/09 (21<sup>st</sup> Feb, 2018).
8. If the specified date for pre-bid meeting, last date of submission and falls on a government holiday then same time on next working day shall be considered for such events. In such case, the validity of bid security shall be considered from already specified last date for bid submission.
9. The Employer reserves the right to accept or reject, wholly or partly any or all the bids without assigning any reason, whatsoever.
10. All other issued shall be considered as per Public Procurement Act 2063 & Public Procurement Regulation 2064 including all latest amendments.
